Food Exhibitor Business Expo 2011: RULES AND REGULATIONS

1. All participants agree to have their booth/s open and operational for the public during the hours of the event, 4:00 p.m. to 7:00 p.m. on November 3, 2011. You may begin set-up at 2:00 pm on Thursday, November 3, 2011. You will be required to have your booth set by 3:30 p.m. **The booth will remain set-up for the duration of the show.**
2. All participants agree to have sufficient food/drink to adequately serve the public during the hours of the event. Last year's event had over 600 attendees.
3. Each participant agrees to supply a sign measuring no less than 12" x 18" for their booth/s listing what they are offering to the public.
4. Each participant agrees to supply their own equipment, **except** for the table and chairs for their booths.
5. All fees are due at the time of registration.
6. All menus are subject to approval by the Lafayette Chamber of Commerce; duplications are subject to review.
7. Electricity is available upon request. Electrical equipment (extension cords, adapters, etc.) **will not** be provided.
8. Vendors must park away from the main entrance of the hotel after unloading supplies.
